

## APPLICATION FORM AS PER LAW ON PERSONAL DATA PROTECTION I. GENERAL DESCRIPTION

Personal data owners (hereinafter referred to as "data owners") who are defined as the relevant persons in Law on Personal Data Protection no. 6698 ("Law") are entitled to certain rights regarding the processing of their personal data in the article 11 of the Law.

Pursuant to 1st paragraph of article 13 of the Law; the applications regarding these rights must be made in written or through other means determined by the Board of Personal Data Protection ("Board") to be submitted to our Company that is responsible for the data. Within this framework, the applications to be made "in written" to our Company must be sent with registered letter with return receipt using this form.
